The ideal candidate will continue to grow the market to enhance social connections with Beaufort and district and provide economic benefit to other local community groups and the business community. Ideally the market will deliver a well curated range of stall holders with a focus on local and handmade goods that could include local fresh produce, baked goods, plants, handmade arts, crafts, tools, furniture, jewellery and, local wine tasting.

EOI applications close: 9am on Monday 24th October.

All applicants will be advised of the outcomes in late November 2022.

EOI terms and conditions

If your application is successful, these terms and conditions will form part of your agreement with Council.

1. Legislative compliance

Successful applicants will be required to comply with all regulations and laws that exist in the State of Victoria regarding holding an event, including permits, licences, and other permissions and approvals as outlined by the Council. Depending on the proposal and location of the Market, these may include but not be limited to:

- Requirements of Local Law Permits
- Public Liability Insurance for no less than \$20,000,000.
- Traffic Management plans, MoA, including installation of traffic management plans.
- Environment Health requirements for all vendors which can include:
 - Food registration
 - Liquor License VCGLR
 - Public Liability Insurance

2. Eligibility Criteria

To be eligible, applicants must be either an:

a. Incorporated not-for-profit community group or organisation located in and within the Pyrenees Shire,

b. Incorporated community group or organisation with auspice support from an incorporated not-forprofit organisation, within the Pyrenees Shire.

c. Businesses registered with an ABN are eligible to make application

3. App	icants	must:

- Have no outstanding legal matters or debts owing to Council.
- Have no unresolved action concerning a notice or order related to a building or environmental health issue, or any compliance issue with a planning permit.
- Have met all acquittal conditions of any previous Council funding.

4. How are applications assessed

- All applications will be assessed in alignment with these Guidelines, the completed Application Form and in any associated attachment.
- Decisions will be based on assessment criteria outlined in this document.
- An Officer Assessment Panel is appointed to assess all applications and will make the final recommendation

5. Outcomes of Applications

- Applicants will be notified in writing of Council's decision, and any conditions of the application agreement (if applicable).
- Those unsuccessful will be provided with a response in writing and offered opportunity to discuss the outcome application process.

Criteria

Assessments are based on merit of the application in response to assessment criteria nominated below.

Consequently, applicants should make every effort to submit a comprehensive application.

Applications will be initially screened for eligibility and provision of required documentation. Any applications that do not meet eligibility requirements will not proceed to the formal assessment phase.
