PURPOSE

The purpose of this report is for the newly elected Councillor of the Beaufort Ward to fulfil the statutory duties specified in section 63 of the *Local Government Act 1989* to enable that person to undertake the duties of Councillor through the taking of the Oath of Office.

BACKGROUND

In accordance with Section 63(1) of the *Local Government Act (1989)* a person elected to be a Councillor is not capable of acting as a Councillor until the person has taken the Oath of Office.

ISSUE / DISCUSSION

A person elected to be a Councillor is not capable of acting as a Councillor until the person has:

- Taken the Oath of Office; and
- Read the Councillor Code of Conduct and made a declaration stating that they will abide by the Councillor Code of Conduct. The declaration must be:
 - o In writing; and
 - Witnessed by the Chief Executive Officer

Oath of Office:

The Oath of Office must be:

- Made before the Pyrenees Shire Council's Chief Executive Officer; and
- Dated and signed before the Chief Executive Officer; and
- Recorded in the minutes of the Council.

The following Oath of Office is to be taken by a Councillor in accordance with Division 2 of Part IV of the Evidence (Miscellaneous Provisions) Act 1958, and Section 63 of the Local Government Act 1989.

"I will undertake the duties of the office of Councillor in the best interests of the people in the municipal district of the Pyrenees Shire and faithfully and impartially carry out the functions, powers, authorities and discretions vested in me under the Local Government Act (1989) or any other Act to the best of my skill and judgement".



PURPOSE

The purpose of this report is for the newly elected Councillor of the Beaufort Ward to fulfil the statutory duties specified in section 63 of the *Local Government Act 1989* to enable that person to undertake the duties of Councillor through the reading and signing of the Councillor Code of Conduct; and

For the existing Councillors of the Pyrenees Shire Council to re-affirm that they will abide by the Councillor Code of Conduct.

BACKGROUND

In accordance with Section 63(1) of the Local Government Act (1989) a person elected to be a Councillor is not capable of acting as a Councillor until the person has read the Councillor Code of Conduct and, in accordance with subsection (3), made a declaration stating that they will abide by the Councillor Code of Conduct.

ISSUE / DISCUSSION

A person elected to be a Councillor is not capable of acting as a Councillor until the person has:

- Taken the oath of office; and
- Read the Councillor Code of Conduct and made a declaration stating that they will abide by the Councillor Code of Conduct. The declaration must be:
 - o In writing; and
 - Witnessed by the Chief Executive Officer

The newly elected Councillor of the Beaufort Ward of the Pyrenees Shire Council must read the Councillor Code of Conduct and make a declaration stating that they will abide by the Councillor Code of Conduct, using the attached declaration.

It is requested that all Councillors of the Pyrenees Shire Council re-affirm their intention to abide by the Councillor Code of Conduct by signing the attached copy of the Code which was adopted by Council on 14 February 2017.


