1. WELCOME

4. ACKNOWLEDGEMENT OF COUNTRY

CEO Jim Nolan acknowledged the traditional owners with the following:

This week is NAIDOC Week which celebrates the history, culture and achievements of Aboriginal people and Torres Strait Islander people. The theme of NAIDOC Week is 'Always Was, Always Will Be' which recognises that first nations people occupied and cared for this country, this continent for over 65 thousand years. On this important day for the Pyrenees Shire and Pyrenees Shire Council, we gather on the land of Dja Dja Wurrung, first nations people whose ancestors walking this very land for thousands of generations. We recognise the rich cultural history of the numerous clans and peoples that comprised Pyrenees Shire. We acknowledge people past and present of the Wadawurrung, Dja Dja Wurrung, Wotjobaluk and Eastern Maar tribes. We pay our respect to the customs, traditions and stewardship of the land by the elders and people of these tribes, on whose land we meet today.

7. 2019/2020 MAYOR'S REPORT

8. ELECTION OF MAYOR

- 8.1 CEO Jim Nolan called for a motion to determine if the term of Mayor is to be for one or two years. Cr Tanya Kehoe moved the motion that the Mayor term will be for one term. Cr Eason seconded the motion. The motion was put to the vote and all were in favour. The motion was carried.
- 8.2 CEO Jim Nolan called for nominations for Mayor for the 2020/2021 term. Cr Vance nominated Cr Ferrari. Cr Ferrari accepted the nomination.
- 8.3 No further nominations were put forward therefore there was no requirement for the nomination to be voted upon.
- 8.4 CEO Jim Nolan declared Cr Damian Ferrari as the duly elected Mayor for Pyrenees Shire Council for the 2020/2021 term.
- 8.5 CEO Jim Nolan invited immediate past Mayor, Cr Kehoe to present Cr Ferrari with the gavel. Cr Kehoe congratulated Cr Ferrari and presented him with the gavel as a symbol of the orderly succession from one mayor / chair to another.
- 8.6 CEO Jim Nolan invited the newly elected Mayor Cr Ferrari, to take the Chair.
- 8.7 Cr Ferrari took the Chair. He expressed his thanks and that it was an honour to take on the position. He thanked Cr Kehoe for her previous 12 months. He noted that she led Council through a very trying time with COVID-19 with professionalism. Her community reassurance and messaging was especially recognised.
