#### 6. 2022/2023 MAYOR'S REPORT

The Mayor, Cr Ron Eason provided a report on the term as Mayor:

"Firstly, I want to thank my fellow councillors for the honour to represent our Shire as Mayor and thanks to the staff for their support and education on matters I could not handle alone. More importantly a great deal of thanks to my wife Jenny for her support along the way.

Our year has been heavy on projects. This year the Lexton Community Hub was completed after many years in the planning, and what a great space we are in tonight. Within our townships, significant additional paths have been created in Avoca and Beaufort to improve accessibility for residents, including around Beaufort Lake. In rural areas, we have successfully completed numerous road upgrades, ensuring safer and smoother travel for our residents and visitors including a number of bridge completions. Also the installation of electric vehicle charging stations in our towns and planting of additional street trees. Along with the ongoing purchase of green power and efficiency measures in council buildings, these have not only reduced our carbon footprint but also resulted in substantial cost savings for the council. We are proud to have taken a step towards a greener future for Pyrenees Shire.

While we celebrate these achievements and others, it is important to acknowledge the challenges we have faced and continue to address. The Flood events of October and November 2022 were widespread across the state and had significant impact across the shire. The communities of Avoca, Lexton, Natte Yallock, Beaufort and Amphitheatre were the most significantly impacted with many homes, local roads, bridges and community facilities damaged. With most of the Pyrenees shire being in the upper reaches of catchments, there is little warning for our communities to respond. With the assistance of our



local contractors, we have commenced the challenging road repair program and continue to do this in a way that maximizes government funding.

Council relies heavily on the state to provide funding support for services such as libraries, emergency management, maternal and child health services, and roadside weeds management. A further effect of the economic climate has seen a major increase in the cost to deliver projects and services. Advocacy for the ongoing commitment by both state and federal governments to fund essential Council services has never been greater and we continue this important advocacy. Council relies heavily on peak bodies such as the Municipal Association of Victoria (MAV) at a state level and the Association of Local Government (ALGA) at a federal level to present a strong and consistent case for sustained and increased funding.

The Western Renewables Link project continues to be the subject of significant community concern across the length of the project including in Pyrenees. Council's advocacy this year included a meeting with Minister D'Ambrosio to highlight these concerns and to table the need for community benefits to be considered by government to offset the impacts of this major infrastructure on rural communities. Other meeting with Ministers have allowed our concerns to be placed on the table of the Government for their action. The cost shifting and rate capping 1 are matters for the Government to decide if they are affecting councills unfairly and I can confirm that both are having a significant effect on our sustainability. In speaking to the Minister for Local Government about the effect she sees going forward she had no answer except to say We need to become more inventive. Inventive is usually a word used to explain when you are caught with your hand in the cookie jar and I am sure the Minister was not meaning that. We do however need more astute guidance from Government and this seems to be in short supply at present but a new Premier may make a difference.

Engaging with our communities has included ongoing commitment by Councillors to meet with residents in our smaller townships through the community cuppa sessions held monthly across the shire. Our Community Development staff also have made a concerted effort over the year to engage more directly with community leaders in their location to understand community priorities and work together to advance their priorities.

A major decision of Council this year, due in part to changes at a Commonwealth program level, was the decision to cease to be a provider of in-home aged care services from 30 June 2023. This was a challenging decision for Council given the quality of service provided by the Council team over many years servicing our most vulnerable residents. This has resulted in a transition to new providers, and farewell to our much-loved Community Care Team. The decision was seen as a loose loose outcome because we believe our support for our customers was far better than they would receive elsewhere. We unfortunately had no option.

In conclusion, I would like to express gratitude to the residents of Pyrenees Shire, the council members, and the dedicated staff for their unwavering support and commitment. Together, we have overcome many challenges and achieved much to be proud of, and we are confident that our collective efforts will lead to a brighter future for our shire.

This is what your council is about and why we meet regularly to work to improve our shire for everyone. There are many more projects that could be talked about but my time has come and we need to look forward and not back. Please help us continue to look to the future positively."



# 7. ELECTION OF MAYOR

CEO Jim Nolan called for nominations for Mayor for the 2023/2024 term. Cr Clark nominated Cr Vance, Cr Eason seconded the nomination. Cr Vance accepted the nomination.

No further nominations for Mayor were put forward therefore there was no requirement for the nomination to be voted upon.

CEO Jim Nolan called for a motion to determine if the term of Mayor is to be for one or two years. Cr Eason moved the motion that the Mayoral term be for one year. Cr Clark seconded the motion. The motion was put to the vote and all were in favour. The motion was carried.

CEO Jim Nolan declared Cr Robert Vance as the duly elected Mayor for Pyrenees Shire Council for the 2023/2024 term.

Cr Eason congratulated Cr Vance and presented the gavel to Cr Vance as a symbol of the role of the Mayor.

CEO Jim Nolan invited the newly elected Mayor Cr Vance, to take the Chair.

Cr Vance thanked Councillors for their confidence in him in electing him as Mayor.

# 8. OFFICE OF DEPUTY MAYOR

The Mayor, Cr Vance called for a motion to declare electing a Deputy Mayor. Cr Clark moved and Cr Ferrari seconded that a Deputy Mayor not be elected for the 2023/2024 term. The motion was put to the vote and all were in favour. The motion was carried.

#### 9. PRESENTATION OF GIFTS

Cr Ferrari presented Cr Eason with a gift in recognition of the Mayoral term.

Cr Ferrari presented Jenny Eason, Cr Eason's wife with a gift in recognition of the support provided to the Mayor over the past year.

Cr Clark presented Cr Eason with the MAV Councillor Service Award for 10 years of service. Cr Clark also presented Cr Eason with the MAV Mayor Emeritus Award.

Cr Clark acknowledged Cr Kehoe for her 10 years of service with the MAV Councillor Service Award to be presented at a later date.

Cr Vance acknowledged Cr Clark for his 25 years of service with his MAV Councillor Service Award previously presented at the MAV State Council Conference.
