## BE A RESPONSIBLE PET OWNER UNDER THE *DOMESTIC ANIMALS ACT 1994*

- Penalty for failing to register a cat or dog over the age of 3 months – up to 20 Penalty Units
- Penalty for dogs wandering – up to 10 Penalty Units
- Penalty for a dog that rushes at, attacks, worries, or chases any person or animal – up to 120 Penalty Units
- Penalty for a dog or cat causing a nuisance – up to 3 Penalty Units
- Penalty for a dog or cat failing to wear a Registration Tag – up to 2 Penalty Units

1 Penalty Unit = \$203.51 (as of July 2026)

### STATE GOVERNMENT LEVY

The above fees include a State Government Levy of \$4.39 for dog and cat registrations. This levy is primarily used to fund responsible pet ownership programs.

### COMPULSORY DESEXING OF CATS

If you own a cat in Pyrenees Shire, it must be de-sexed. Council is unable to register a cat unless it is desexed. Exemptions will only be made for cats covered by the *Domestic Animals Act 1994* Section 10B. Desexing your cat will help reduce the number of stray and unwanted cats.

### CONCESSION

If you wish to claim a concession you must supply proof of your Centrelink or Department of Veterans Affairs Pensioner Concession Card. Health Care cards are not accepted.

### REGISTRATION OF FARM WORKING DOGS

#### DOG OWNERSHIP CRITERIA:

1. Are you, or are you contracted by, a primary producer ?
2. Is your main source of income generated from primary production ?

If you answered NO to either of these questions, your dog does not qualify as a work dog and it cannot be registered as a working dog.

*Primary production is defined as the maintenance of animals or poultry for the purpose of selling them or their natural increase or bodily produce under Section 3 of the Domestic Animals Act 1994.*

#### FARM WORKING DOG CRITERIA:

1. Does your dog herd, drove, protect, tends or work stock ?
2. Does your dog work (as per definition below) on land used mainly for primary production ?

If you answered NO to either of these questions, your dog does not qualify as a work dog and it cannot be registered as a working dog.

*Farm working dog means a dog that herds, droves, protects, tends or works stock on land used solely or primarily for primary production under Section 3 of the Domestic Animals Act 1994.*
