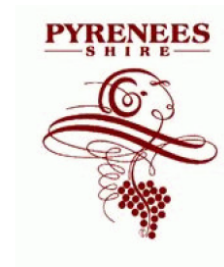

If you are applying for a permit renewal please complete this form and submit it at least 28 days before the expiry date of the existing permit.

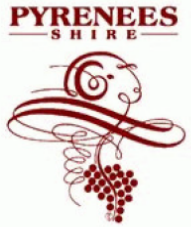
